### **ITEM IDENTIFICATION:**

Tuition Fee Schedule for Self-funded Programs 2023-24

#### JURISDICTIONAL INFORMATION:

Pursuant to Section 5.11 (a) the Business Board recommends the schedule of tuition fees to Governing Council for approval.

### **PREVIOUS ACTION TAKEN:**

The *Tuition Fee Schedule for Self-funded Programs 2022-23* was approved by the Governing Council at its meeting on March 31, 2022.

### HIGHLIGHTS:

The University offers a number of programs that are not eligible for funding under the Ministry's operating grants program, and, as a consequence, their fees are not regulated. The programs are self-funded and tuition fees are set at levels necessary to cover the full costs and consider fees in similar programs at other universities. Annual changes in tuition fees reflect not only inflation

but may also reflect variations in real costs as programs and services change. The proposed fee levels and year-over-year increases for self-funded programs are described in Table 1.

#### FINANCIAL IMPLICATIONS:

Revenue projections for self-funded programs are included in the *Budget Report 2023-24 and* Long-Range Budget Guidelines 2023-24 to 2027-28.
