ITEM IDENTIFICATION:

Tuition Fee Schedules for Publicly-funded Programs 2024-25

JURISDICTIONAL INFORMATION:

Pursuant to Section 5.11 (a) the Business Board recommends the schedule of tuition fees to Governing Council for approval.

PREVIOUS ACTION TAKEN:

The *Tuition Fee Schedules for Publicly-funded Programs 2023-24* was approved by the Governing Council at its March 30, 2023 meeting.

HIGHLIGHTS:

Tuition revenue in publicly-funded programs of \$2.1 billion for 2024-25 represents approximately 60% of the University's total budgeted operating revenue of \$3.52 billion.

Tuition fees at the University of Toronto are determined in accordance with the University's *Tuition Fee Policy*, the *Statement of Commitment Regarding International Students* and the Provincial Government's Tuition Framework. The *Tuition Fee Policy* speaks to five elements: advocacy, fee revenue, fee differentiation, fee level commitment and monitoring. In presenting this tuition schedule, the University reaffirms its commitment to student aid for domestic students and its accessibility statement. A full overview of financial assistance available to students is included in the 2022-23 *Annual Report on Student Financial Support*, which accompanies these schedules through governance.

Note that the tuition fees in these schedules are limited to for-credit publicly-funded programs. Fees for non-credit continuing education or life-long learning programs are established locally within the relevant divisions and the School of Continuing Studies and are not discussed in these schedules.

Domestic Tuition Fees

On January 17, 2019, the Ontario government announced a 10% cut to domestic tuition fees beginning in 2019-20, and a freeze at that level for 2020-21. The freeze was subsequently extended for three additional years for Ontario resident domestic tuition to 2023-24. The cumulative impact of the 10% cut in 2019-20 and four-year freeze is a \$195 million reduction in annual operating revenue to the University in 2023-24 compared to the framework in place before 2019-20. Our domestic fees continue to be lower than they were in 2018-19 and, after inflation, tuition for Arts & Science programs is lower than it was in 1999.

In March 2023, the Provincial Government announced the creation of a Blue-Ribbon Panel (BRP) to provide advice to the Minister of Colleges & Universities on how to help keep the postsecondary education sector financially strong and focussed on providing the best student experience possible. The Panel published its final report in November 2023 containing a number of operating grant and tuition recommendations, including the unfreezing of domestic tuition with a 5% increase to undergraduate programs and 8% for professional programs with future increases after that linked to CPI. The Panel Chair also recommended the deregulation of tuition at the University of Toronto in recognition of its pre-eminence and long-standing commitment to access.

However, on February 26, 2024, The Government announced a three-year extension to the Ontario resident domestic tuition freeze. This is a \$15 million impact to the University's original plans for next year that had assumed a modest 3% increase to Ontario resident tuition. At the same time, the Government also announced a 7% increase to operating grants over three years which will roughly offset the financial impact of the extension of the freeze. As a result, the 2024-25 Budget assumes increased operating grant funding of \$15 million to offset the financial impact of the extension of the tuition freeze. Consistent with the Frameworks in place since 2021-22, the University is planning on a 5% increase to Non-Ontario Resident domestic tuition in undergraduate programs in 2024-25.

The 2024-25 plan also includes an increase of 7.5% for incoming tuition in our doctoral stream Master of Arts and Master of Science programs, as well as the MSc in Applied Computing, as approved by the Government under the tuition anomaly adjustment provision in their 2023-24 Framework. This Province-wide provision allows for special increases to tuition where it is significantly lower than comparable programs in Ontario. Tuition increases for continuing students will be limited to a maximum of 5% per annum under the University's internal policy commitment to continuing students.

International Tuition Fees

International fees are set at a level that takes into consideration the full cost of providing a program and with reference to fees at peer Canadian and US universities.

Overall, undergraduate international tuition fees will increase by an average of 2.1% and graduate international tuition fees will increase by an average of 3.5%, excluding international PhD students paying domestic rates, and 2.2% when international PhD fees are included. In order to provide potential applicants with information for planning purposes, the attached schedules also include currently planned tuition fees for international students for 2025-26 **for information only**.

International tuition fees for students entering and continuing in the tri-campus Arts & Science, Architecture, and Information programs will increase by 2% in 2024-25. Tuition for Applied Science & Engineering and Medicine MD degree programs will increase by 3% for new and continuing students. Most other international fees will increase by 5%, consistent with the assumptions in last year's plan and reflecting their lower fee levels. International fees for all of the conjoint programs with the Toronto School of Theology will increase by 5% for 2024-25.

As is the case with domestic tuition fees, international tuition fees for the second and upper years of the Commerce, Business Administration, Management, Computer Science, Bioinformatics, Data Science, UTM

Visual Studies, and Communication, Culture, and Information Technology (CCIT) programs are differentiated from the first-year general arts & science fee. These fees will increase by 2% in 2024-25.

As of 2018-19, most international PhD students at the University of Toronto pay tuition fees equivalent to those of domestic students and the fees will continue to be aligned for 2024-25.

International tuition fee increases in research-stream master's, professional master's, and professional doctoral programs vary by program, but primarily range from 3% to 5%, with higher increases in entering fees for the MSc in Applied Computing (8.5%) and MSW (6%). Fee increases consider the resource requirements of the programs and the level of the tuition fee relative to competing programs. Fee increases for continuing students are limited to a maximum of 5% under the University's policy.

FINANCIAL IMPLICATIONS:

Revenue projections for publicly-funded programs are included in the *Budget Report 2024-25 and Long Range Budget Guidelines 2024-25 to 2028-29*. Related information on student aid accompanies this report in the *Annual Report on Student Financial Support*, 2022-23.

Tuition Planning and Context

The following report provides the proposed tuition fees for for-credit degree, diploma, and certificate programs at the University of Toronto for 2024-25. An overview of the policy frameworks and context for fee setting is included along with detailed schedules of the fees in the appendices. Note that the tuition fees in this report are limited to for-credit programs. Fees for non-credit continuing education or life-long learning programs are established locally within the relevant divisions and the School of Continuing Studies and are not discussed in this report.

Tuition fees at the University of Toronto are determined in accordance with the University's Tuition Fee Policy, the Statement of Commitment Regarding International Students, and the Provincial Government's Tuition Framework.

The Provincial Framework for Domestic Tuition Fees

Changes to domestic tuition fees in publicly funded programs at Ontario colleges and universities are subject to frameworks mandated by the Provincial Government. Under these frameworks, the Government sets limits on increases to fees (and in some cases, requires reductions or freezes) and retains the option to reduce operating grant funding to institutions that contravene the framework. The frameworks only apply to tuition for students for which the Government provides operating grant funding so do not apply to the majority of international students, non-publicly funded programs such as the Executive MBA, and continuing education programs.

On January 17, 2019, the Ontario government announced a 10% cut to domestic tuition fees beginning in 2019-20, and a freeze at that level for 2020-21. The freeze was subsequently extended for three additional years for Ontario resident domestic tuition to 2023-24. Tuition paid by international students was unaffected.

The cumulative impact of the 10% cut in 2019-20 and the four-year freeze is a \$195 million reduction in annual operating revenue to the University in 2023-24 compared to the Framework in place before 2019-20. Our Ontario resident domestic fees continue to be lower than they were in 2018-19 and after inflation, our fee for Arts & Science programs is lower than it was in 1999.

In 2021-22, the Government introduced a new policy allowing for differentiated fees for Out of Province or "non-Ontario resident" domestic students. Given the lateness of the announcement of the fee framework, coming at the start of the Summer 2021 session, the University opted to not implement differentiated fees for 2021-22. However, the University proceeded with establishing differential fees for non-Ontario resident domestic students in 2022-23, with a 3% increase to fees for all undergraduate programs while fees for domestic Ontario resident domestic fees in undergraduate programs were increased by 5% in 2023-24 under the framework.

In Fall 2023, the Government released the recommendations of its Blue-Ribbon Panel which included increasing domestic fees by 5% for undergraduate programs and 8% for professional programs, a 10% increase to operating grants, future enrolment growth funding, and special consideration for the University of Toronto on tuition.

However, on February 26, 2024, The Government announced a three-year extension to the Ontario resident domestic tuition freeze. This is a \$15 million impact to the University's original plans for next year that had assumed a modest 3% increase to Ontario resident tuition. At the same time, the Government also announced a 7% increase to operating grants over three years which will roughly offset the financial impact of the extension of the freeze. As a result, the 2024-25 Budget assumes increased operating grant funding of \$15 million to offset the financial impact of

the extension of the tuition freeze. Consistent with the Frameworks in place since 2021-22, the University is planning on a 5% increase to Non-Ontario Resident domestic tuition in undergraduate programs in 2024-25.

The 2023-24 Framework included a new process for institutions to request multi-year tuition anomaly adjustments where a program's tuition rate was at least 15 per cent lower than the sector average of comparable programs. Tuition fees for approved anomaly programs can be increased up to 7.5% per year until they reach the approved level.

The University received approval for special anomaly increases for tuition in our doctoral stream Master of Arts and Master of Science programs, as well as the MSc in Applied Computing which are all significantly below comparable programs in Ontario. The University increased incoming domestic fees by 3 per cent for Fall 2023, as per the Schedule 2 of approved fees for that year and will increase fees by 7.5% in 2024-25. Tuition increases for continuing students will be limited to 5% per annum under the University's internal policy commitment to continuing students.

Tuition Revenue

The 2024-25 Budget includes incremental, for-credit tuition fee revenue of \$48 million. This reflects the net impact of updated international and domestic enrolment plans, a continued freeze to Ontario resident domestic tuition fees, a 5% increase to non-Ontario resident undergraduate domestic fees, the special anomaly increases described earlier, and a 2.1% average increase in international tuition fees. With the continued limitations on per-student operating grant revenue, new tuition revenues are critically necessary to maintain and fund investments in programs and services for students across the University.

The University continues to monitor the impact of tuition fees to ensure that enrolment is unaffected, as required by the University's Tuition Fee Policy. Demand for University programs from both domestic and international students continues to be strong and undergraduate entering averages continue to be exceptional. The most recent statistics from the Ontario Universities Application Centre (OUAC) show that 45% of new U of T students have a 90%+ high school average, and 1 in every 5 high school graduates with a 90%+ average enrolling in an Ontario university enrols at the University of Toronto.

Financial Aid

Undergraduate and graduate students at the University of Toronto have access to a wide range of financial supports through the University in addition to those available through government loan and grant programs like the Ontario Student Assistance Program (OSAP). Some are based on need, and others on measures of merit, such as academic achievement or leadership. There are supports for international and Canadian students as well as dedicated supports for students with disabilities.

The University of Toronto is independently committed to financial aid and is guided by the 1998 Governing Council Policy on Student Financial Support, which will continue to drive funding for need-based student aid for domestic students.

The policy sets out the principle that domestic students should have access to the resources that will enable them to meet their financial needs, as determined through the Ontario Student Assistance Program (OSAP), with appropriate modifications as determined by the Vice-Provost, Strategic Enrolment Management and the University Registrar, in consultation with the academic divisions of the University. The Province's Student Access Guarantee (SAG) requires institutions to provide non-repayable aid to assist domestic, OSAP-eligible students in direct-entry undergraduate programs with expenses related to tuition, books and supplies not covered by OSAP. The University's commitment goes above and beyond these requirements and also provides support for living expenses.

The University's primary mechanism for providing need-based aid to OSAP-eligible, direct-entry, domestic undergraduate students is the University of Toronto Advance Planning for Students (UTAPS) program, which supported more than 15,000 students in 2022-23. Need-based aid for domestic students in second-entry and professional master's programs is administered in divisionally-run programs, allowing for a more individualized and nuanced approach to providing assistance. Divisional programs are supported where necessary by access to an institutionally negotiated line of credit.

University practice in recent years has been to link the change in the UTAPS budget to the domestic fee framework. As the budget assumes a freeze to undergraduate Ontario resident domestic fees, the budget provision for UTAPS will be frozen accordingly at \$41 million which is then topped up by about \$2 million in funding from restricted accounts including the Boundless Promise Program. While UTAPS is the primary program to meet student financial needs, the University provides additional funding outside of UTAPS to support students facing unexpected financial challenges.

In 2023-24, the University made significant changes to the UTAPS program to make it more responsive to student needs and less impacted by changes in the Government's OSAP need assessment policies. These changes give the University greater flexibility to grant financial support earlier and to consider more accurate living costs for the GTA in need calculations.

The large direct entry undergraduate divisions have committed to a significant investment in merit-based scholarships for international students from diverse global regions. Divisions are earmarking 6% of total international undergraduate tuition to support International Scholars awards to reduce the cost for top international applicants from around the world. Each division has designed its own awards program based on diverse criteria including merit, financial need, priority regions for diversification, and intended program of study. The 2024-25 Budget sets aside \$90 million for the International Scholars program and the full-ride Pearson Scholarships for exceptional international students.

Additional information on the University's student aid programs and OSAP can be found in the 2022-23 Student Financial Aid Report.

University of Toronto Fee Level Commitment

The University's Tuition Fee Policy (Appendix A) states that in establishing the tuition fee schedule, a commitment will be made to each student upon entry as to the level of fees to be charged over the normal course of the full-time program of study. Beginning in 1998-99, the University of Toronto made a commitment to students in its fee schedules that, unless otherwise noted, no student continuing in a program will be subject to a fee increase of more than 5% per year.

This commitment remains in effect regardless of the provincial tuition framework in place at any given point in time and applies for the normal length of each program, as posted on the University's website. For students in the doctoral stream, the commitment is in effect for two years at the Master's level and typically for four years at the doctoral level (with some exceptions for longer doctoral programs). For students who participate in Co-op or internship programs as part of their undergraduate program, the normal length of full-time study increases by one year. For undergraduate students entering the University via an International Foundation Program, the normal length of study also increases by one year.

Tuition Fee Structures

Program Fees and Course Fees

Full-time undergraduate student fees are levied in one of two ways: program fees or course fees. Under a program fee structure, students pay a single fee for study classified as full-time for fee purposes. Under a course fee structure, students pay a fee for each course in which they are registered. Most University of Toronto programs levy fees under the program fee model.

Programs with higher fees in upper years

In some undergraduate programs, students are admitted after completing one or more years of study in arts and science courses. During the initial year(s), students pay general arts and science tuition; upon admission to the program, students pay a higher tuition fee in upper years. This structure reflects the move from a general program to an upper-year specialized program. These programs include: Commerce; Business Administration; Management; Computer Science; Bioinformatics; Data Science; UTM Visual Studies; Communication, Culture and Information Technology (CCIT); and the undergraduate program in Information.

Bachelor of Information (BI) students complete the equivalent of two years of full-time study at the undergraduate level in any discipline before transferring into the BI program. Once registered in the BI program, students pay the same tuition as Computer Science students.

Combined, Double Degree, and Dual Degree Program Fees

The University has a number of combined degree program offerings and has begun to develop additional double degree and dual degree programs. Schedules B4 & D5 provide detailed information on fees for these programs. The proposed fees by year of study for almost all cases are based on the fees for the constituent programs proposed in Schedules B1-B3, C, & D1-D4.

Part-Time and Partial Fees

Some students at the University of Toronto are charged partial fees primarily based on the tuition fee for full-time study. The following formulas guide the derivation of partial fees:

- When computing a partial fee, the respective fee for fulltime study is the tuition fee for either domestic or international students, depending on the legal status of the student.
- Part-time fees for undergraduate programs are typically equal to the full-time fees pro-rated on a per-course basis relative to the full-time course load, except in a couple of special cases.

- The program fee for part-time domestic MD
 Extended Clerkship students is assessed on a per
 term basis, typically in the summer and fall terms.
 No international students are expected in this
 program.
- Fees for the part-time domestic PharmD for Pharmacists program are assessed on per half course basis.
- 3. Part-time fees for graduate programs are normally set at 30% of the full-time annual fee with the following exceptions:
 - The Nursing Post-Masters Nurse Practitioner
 Diploma program is offered on a part-time basis
 only and fees are assessed on a program fee basis.
 - The part-time Medicine Graduate Diploma in Health Research is available to MD students and fees are assessed on a per term basis.
 - The UTM Master of Forensic Accounting is only offered on a part-time basis. The proposed parttime program fee rates for 2023-24 are listed in Schedules C & D4.
- 4. Because of the minimum costs incurred for registration in any program, no tuition fee in 2024-25, after refunds in the case of full withdrawal from the University, shall be less than \$329.

Conjoint Programs with the Toronto School of Theology

In accordance with the Memorandum of Agreement between the University of Toronto and the Toronto School of Theology (TST), proposed tuition fees for conjoint undergraduate and graduate programs are forwarded to the Business Board for review and approval annually – these fees are included in the accompanying schedules.

Note that tuition fees for TST's non-conjoint programs are not included as these are not University of Toronto programs. Approval for these fees is through the TST Board of Trustees.

2024-25 Tuition Fees

Tuition Fees for Domestic Students

The University's Tuition Fee Policy (Appendix A) states that public funding should be supplemented as necessary to offer students an educational experience of a quality that ranks with that of the finest public research universities in the world. Furthermore, it calls for a differentiated fee structure in which tuition fees reflect individual program goals, resource requirements, program costs, etc.

Tuition fees therefore differ by program. Appendix B Undergraduate Domestic Tuition Fee Schedules list the proposed tuition fees for domestic students by residency, by program, and by entering cohort where relevant. For the purposes of this report, direct-entry undergraduate programs are programs of study into which a student may be admitted directly from high school (e.g., Engineering, Arts and Sciences, Architecture, Music, and Kinesiology) plus the Transitional Year Program (TYP). Second-entry undergraduate programs are programs of study that require a student to have some university preparation before admission to the program (e.g., Law JD, Medicine MD, Dentistry DDS, PharmD and Nursing). Graduate fees are listed in Appendix D.

Undergraduate students entering first year in 2024-25 should note that tuition fees for upper year students in the Commerce, Business Administration, Management, Computer Science, Data Science, Information, Bioinformatics, Visual Studies, and Communication, Culture, and Information Technology (CCIT) programs are provided separately in Schedules B2. Fees for the upper years of these programs in 2024-25 will be submitted to Governing Council for approval in Spring 2025 and will comply with the Provincial Tuition Framework in place at that time.

Tuition Fees for International Students

The University of Toronto is committed to maintaining and strengthening its international enrolment as expressed in the Statement of Commitment Regarding International Students (Appendix A). The University continues to invest in services to enhance the experience and success of our international students and in scholarship programs to attract and support top students from across the world. The proposed international fees listed in Appendix D are set at a level that takes into consideration the full cost of providing a program and with reference to fees at peer Canadian and US universities.

The international tuition fees for students entering and continuing in the tri-campus Arts & Science, Architecture, and Information programs will increase by 2% in 2024-25. Tuition for Applied Science & Engineering and Medicine MD degree programs will increase by 3% for new and continuing students. Most other international fees will increase by 5%, consistent with the assumptions in last year's plan and reflecting their lower fee levels. International fees for all conjoint programs with the Toronto School of

Theology will increase by 5% for 2024-25. The weighted average undergraduate international tuition fee increase across all programs and years of study in 2024-25 will be 2.1%.

As is the case with domestic tuition fees, international tuition fees for the second and upper years of the Commerce, Business Administration, Management, Computer Science, Bioinformatics, Data Science, UTM Visual Studies, and Communication, Culture and Information Technology (CCIT) programs are differentiated from the first year general arts & science fee. These fees will increase by 2% in 2024-25.

As of 2018-19, most international PhD students at the University of Toronto pay tuition fees equivalent to those of domestic students and the fees will continue to be aligned for 2024-25. International tuition fee increases in research-stream master's, professional master's, and professional doctoral programs vary by program, but primarily range from 3% to 5%, with higher increases in entering fees for the MSc in Applied Computing (8.5%) and MSW (6%). Fee increases consider the resource requirements of the programs and the level of the tuition fee relative to competing programs. In all cases, continuing fee increases are limited to a maximum of 5% under the University's policy.

In response to competitive pressures from peer programs, international fees for the Master of Biotechnology, Master of Management and Professional Accounting, Master of Accounting and Finance, Master of Forensic Accounting, Master of Management of Innovation, Master of Management in Urban Innovation, and the Master of Science in Biomedical Communication programs will remain at their current levels for 2024-25.

The weighted average tuition fee increase for international graduate students, excluding international PhD students paying domestic rates, in 2024-25 is 3.5%. When international PhD programs are included, the average increase in international graduate fees is 2.2%.

Schedule D5 includes the international fees for students in combined, double degree or dual degree programs. Most combined programs do not currently have international students enrolled. If they do in future, international tuition fees would be charged following the same practices as outlined in the domestic Schedule B4.

Planned 2025-26 International Tuition Fees for Information Only

The University provides a supplemental schedule of currently planned fees for 2025-26 **for information only** to assist students considering applying to the University in the future. Note that these fees are subject to change when the University finalizes its plans next year.

For planning purposes, undergraduate arts & science international fees are projected to increase by 2% in 2025-26 and 3% for undergraduate engineering programs, with variations in other programs to reflect competitive environments (lower rate of increase) or exceptional resource requirements (higher rate of increase).

Appendix A: Policies

The University's Tuition Fee Policy

The University of Toronto's tuition fee policy should reflect its mission as an internationally significant, public research university with undergraduate, graduate and professional programs of excellent quality. Such a goal assumes an appropriate level of funding which, for a public university, means principal support from the Provincial and Federal Governments, and from endowment funds as well as tuition fees. It also assumes the existence of programs of student aid to maintain the accessibility of the University to students of varying financial means. The effect of this policy should be neutral with regard to enrolment levels, which will be determined from time to time through the University's planning processes. Our tuition fee policy has five elements:

- Advocacy. In making the case for public policies strongly supportive of an accessible public system of university education, the University will continue to advocate ongoing and substantial public investment in the university sector.
- 2. Fee Revenue. The University of Toronto will continue to be a public university, for which ongoing and substantial support from government will always be essential. The basic principle of the tuition policy is that public funding should be supplemented as can be demonstrated to be necessary to offer students an educational experience of a quality that ranks with that of the finest public research universities in the world.
- 3. Fee Differentiation. The University should continue to move toward a more differentiated structure of fees across programs. In setting fees for each particular program, the following factors will be taken into account:
 - Fees should take into account the plans and aspirations of each academic division, and the level of resources necessary to achieve high program quality.
 - Program costs should be taken into account in setting fees.

- Fees should be set at a level that is competitive with programs of similar quality in institutions with which we compete or expect to compete for students.
- Fee levels should be relatively higher in programs for which the future income prospects of graduates are relatively higher.
- Fee levels should reflect a justifiable balance across public and private sources of revenue per student.
- Fee policy should allow for intentional, disproportionate public subsidies and intrauniversity cross-subsidies, where a case for crosssubsidization can be made.

In bringing forward the tuition fee schedule each time, the administration shall provide an explanation taking account of the above factors.

- 4. **Fee Level Commitment.** The tuition fee schedule will include a commitment to be made to each student upon entry as to the level of fees to be charged over the normal course of the full-time program of study.
- Monitoring. In presenting the annual Report on Enrolment, the Vice-President and Provost shall include commentary regarding the effects, if any, of changes in tuition fees upon changes in enrolment.

Statement of Commitment Regarding International Students

Preamble

International students are an essential feature of the University of Toronto's participation in international scholarship. They contribute to the international character of the University's research and provide opportunities for the international exchange of knowledge through its teaching programs. The presence of outstanding students from all parts of the world in the University's undergraduate and graduate, professional, and research programs, helps to achieve the excellence the University seeks to assure for all its activities. On the University's campuses international students also make an important and positive contribution to the cultural life of the community and create lasting relationships of benefit to individuals as well as to the institution and the country generally. And finally, by enrolling international students, the University of Toronto, as an internationally significant university, has an opportunity to share its educational resources with other countries whose institutions are still evolving.

In light of these considerations, the Governing Council has adopted the Statement of Commitment Regarding International Students that commits the University to enrolling a broad mix of international students in its programs, and that articulates the basic principles that will guide their admission to the University, arrangements for their financial support, right of access to academic courses and programs, and the provision of services to address their particular needs.

This Statement of Commitment applies to University of Toronto students in university degree, diploma and certificate programs who are not Canadian citizens, permanent residents, or convention refugees.

Statement of Principles

- Within the Framework of divisional academic plans, the University of Toronto welcomes international students into all of its programs.
- 2. The admission of international students will be consistent with the Policies and Principles for Admission to the University of Toronto approved by the Governing Council in 1991.
- 3. The University will broaden and strengthen its recruiting efforts abroad.
- 4. Once admitted to the University, international students will have access to the same range of courses and support services on the same basis as other students.

Financial Support

- International students who are admitted and enrolled may encounter financial emergencies and the University will provide financial assistance as needed and where possible.
- The University will develop a program of international admission scholarships using its own resources and support from external sources to be awarded on the basis of exceptional academic merit and financial need.
- 3. The Report of the Vice-Provost, Students on Student Financial Support, submitted annually to governance for information, will include data on the support provided to international students.

Accompanying Notes to Tuition Fee Tables:

1. Tuition fee rates for each year are effective May 1st. For example, the tuition fees for 2024-25 commence in the Summer 2024 session.

2.

- A. Tuition fee increases for domestic students are to comply with both the Provincial Tuition Fee Framework, and the University's internal Fee Level Commitment to continuing students. The Fee Level Commitment ensures increases of no more than 5% annually for in-program students, guaranteed for the normal length of a full-time program. Students who exceed the normal length of their program are charged the same tuition as students in the final year of that program.
- B. The 2023-24 Provincial Tuition Framework approved multi-year domestic tuition fee increase anomaly adjustments for most MA and MSc programs, as well as the MSc in Applied Computing. Domestic fees for students in these programs may increase by up to a maximum of 7.5% per annum until the University's rates equalize with approved university peer program sector averages as determined by the Ministry (MSC in Applied Computing \$17,320; MA/MSc \$7,600). The University will limit fee increases for continuing students in these anomaly programs to a maximum of 5% per annum under its internal Fee Level Commitment policy.
- C. Due to the late Ministry announcement of the 2023-24 Tuition Framework's tuition fee increase anomaly adjustment process, the approved changes could not be implemented until Fall 2023/Winter 2024. Consequently, graduate doctoral stream Master spring start programs will be unable to fully equalize their domestic tuition rates with the Fall start anomaly programs until 2027-28.

- 3. Bachelor of Information students will first complete at least the equivalent of two years of full-time study at the undergraduate level in any discipline. The lowest 3-campus A&S Year 1-2 fee rates are displayed for demonstration purposes. BI students will then pay the same tuition as Computer Science students.
- 4. TST Undergraduate Basic Degree Program students who entered prior to 2017 will be charged slightly lower fees than the posted rate for 2024-25 above based on the grandparenting rules that existed at their date of entry and compliant with the annual increase limits allowed by the Tuition Frameworks.
- 5. The combined degree programs involving the three Arts & Science campuses' HBA or HBSc programs are restricted to specific combinations of specialist, major, or minor programs. Please refer to the respective divisional academic calendar for further details.
- 6. Includes co-op and non co-op programs.
- 7. The Dental Biomedical Sciences field is for students in the Dentistry MSc and PhD who are not also undertaking concurrent clinical specialty training.

- A. After minimum registration, in Yr 3 & onwards students are subject to the prevailing Yr 2 doctoral stream masters fee.
- B. After minimum registration, in Yr 4 & onwards students are subject to the prevailing Yr 2 doctoral stream masters fee.
- C. After minimum registration, in Yr 5 & onwards students are subject to the prevailing Yr 2 doctoral stream masters fee.
- D. After minimum registration, in Yr 5 & onwards students are subject to the prevailing Yr 5 doctoral fee.
- E. After minimum registration, in Yr 7 & onwards students are subject to the prevailing Yr 5 doctoral fee.
- 9. After Year 8, MD/PhD students are subject to the prevailing doctoral stream tuition fee rates.
- 10. Each MGA combined degree program cohort will start in the prior Fall at the other institution and then register as MGA students at UofT in the following Summer. UofT continuing student fees will be levied in Fall/Winter Year 2.
- 11. In the event a MD/MBA student is able to register in a graduate half course in the Fall term of Year 5, no MBA tuition will be charged.
- 12. The first cohort started in January 2018 at the Universidad Torcuato Di Tella in Argentina and then will register at UofT after 4.5 years. UofT LLM fees will be levied for the first time in Fall 2022/Winter 2023.
- 13. Each cohort will pay tuition at CMU in Year 1, tuition at UofT in Year 2. Students will only be registered at UofT in the Fall term of the third year of time so will be charged 50% of the prevailing MEd continuing student tuition fee rate.
- 14. The first cohort will start in Fall 2023 at the China Medical University and then be registered as MEd students at UofT in Fall 2024. UofT fees will not be levied until Fall 2024/Winter 2025. Each cohort will pay tuition at CMU in Year 1, tuition at UofT in Year 2. Students will only be registered at UofT in the Fall term of the third year of time so will be charged 50% of the prevailing MEd continuing student tuition fee rate.
- 15. Each cohort will pay tuition at ZJU in Year 1, tuition at UofT in Year 2. Students will only be registered at UofT in the Fall term of the third year of time so will be charged 50% of the prevailing MEd continuing student tuition fee rate
- 16. Each cohort will start in the prior Fall at the Sapienza Università di Roma (Italy) and then be registered at the Universidade do Porto (Portugal) or Université Paris-Saclay (France) in Winter and Summer of Year 1. Students will register at UofT in Year 2 for three terms. UofT continuing student (Year 2) fees will be levied in Year 2 Fall/Winter.
